Formula Sailors must register the one board and of each of up to 3 sails they will use at each event. These may change from event to event and that is why you do not have to register them here.

During the season you may change your fleet and class if you so desire (maybe you bought new gear.) In most cases you will not be allowed to keep your scores from previous events. Two examples you would be allowed to keep your scores are; 1) going from Sport 7.5 to Sport Unlimited, 2) going from master to open. Final Divisions for each fleet will be determined by the number of entries in each and are at the discretion of the series organizer. This determination will take place prior to the final event of the season. **(Please see page 2 for Waiver Agreement.)**
